ADDENDUM TO ORDER FORM – TERMS AND CONDITIONS

1. **OUT OF THIS WORLD GAMES ACCEPTANCE OF YOUR ORDER:** By signing this order form you agree that you have read and agree to the terms and conditions printed on this form. No different terms will be accepted by Amberg Entertainment, Inc / Out of This World Games (AE/OOTWG) without written consent of authorized AE/OOTWG personnel. AE/OOTWG is not responsible for typographical errors made on any of its documents, quotations, advertisements, or literature.
2. **PAYMENT:** Payment shall be made on all AE/OOTWG product(s) as follows unless otherwise noted on this form by an authorized representative of AE/OOTWG. All funds will be paid in US Dollars by certified funds, money order, bank wire transfer, cash or credit card (Visa, Mastercard, Discover, American Express accepted). A 50% down payment in secured funds is required on all orders to secure a space in the production schedule. Payments of final balances and shipping charges will be due at least one week before delivery or shipment of product(s).
3. **SHIPPING:** Any ship date indicated on this order form or quoted by any AE/OOTWG personnel at any time is only an estimate and should not be construed as a guarantee. **DO NOT BOOK, RESERVE, RENT, LEASE, SELL OR OTHERWISE ENCUMBER YOUR PRODUCT(S) ORDERED BEFORE YOU RECEIVE THEM.** AE/OOTWG is not liable for any revenues lost or expenses incurred by you in so encumbering any product(s) that have been purchased from us but not received by you. AE/OOTWG uses the services of several shippers to handle delivery of their product(s). Unless a specific carrier is chosen by you, we will use, at our own discretion, any shipper we choose to get the product(s) to you. Shipping charges will be quoted to you by AE/OOTWG at which time you can elect to arrange your own shipping. If you choose to arrange your own shipping, it must be arranged and executed within one (1) week of notification of availability of product. Buyer is responsible for any applicable sales taxes, customs duties, or other fees or taxes arising from the purchase or shipment of any AE/OOTWG product. AE/OOTWG is not responsible for delays in shipping due to weather, acts of God, terrorist acts, government, customs, etc. You must notify AE/OOTWG prior to making final payment if you need a lift gate style truck to unload your order. Please note that there may be additional shipping charges for a lift gate style truck. Inspect your product immediately upon arrival. Damages caused by or in shipping are not the responsibility of AE/OOTWG. You must seek restitution for shipping damage through the shipper responsible according to their policies and procedures. If no such damage claim or warranty claim is made within 72 hours of delivery, the product will be deemed to be delivered in an acceptable condition.
4. **PRODUCT DEFECTS, DAMAGE, AND CHANGES:** Any and all AE/OOTWG Inflatable product(s) do not include any required blowers. Blowers must be purchased separately. Please inspect your product(s) immediately upon receipt. Any damage that occurred in shipping should be immediately reported to the shipper. Any defect(s) in material or workmanship must be reported to AE/OOTWG within 72 hours of receipt or they will not be accepted. AE/OOTWG has the right to require photographic evidence of said defect(s) to aid us in determining a course of action in accordance with our warranty terms. AE/OOTWG may from time to time make changes to product design, color, material, features, method of manufacture, artwork, or in other ways. Please note that the product(s) you receive may vary in design, color, material, features, method of manufacture, artwork, or in other ways from that which was represented to you either in sample, photograph, drawing, or description at the time of sale. Said changes will not affect basic intended function of product(s).
5. **CANCELLATION POLICY:** You may cancel your order in whole or in part upon written notice to AE/OOTWG within 72 hours of the date of your order. After 72 hours of the date of your order, all sales are considered final and non-cancelable. If in the event of extreme extenuating circumstances AE/OOTWG approves a cancellation, your order will be subject to a cancellation fee. For non-custom orders the cancellation fee shall be the amount of any and all monies paid to AE/OOTWG on the product(s) purchased. For custom orders there will be no cancellation for any reason. Once a product is deemed delivered in acceptable condition pursuant to #3 above, there will be no exchanges, refunds, or returns except under the terms of #6 below concerning a covered warranty issue.
6. **WARRANTY:** All products sold by AE/OOTWG are guaranteed to be free of defect in both material and workmanship for a period of one year from the date of delivery of the product(s) except blowers which are covered under their own manufacturers warranty. Any defect or damage to any AE/OOTWG product resulting from improper usage, negligence, or unusual wear and tear caused by excessive usage, or the unit being packed wet is excluded from AE/OOTWG's warranty coverage. Color fading of any material or product of AE/OOTWG is also not covered. The use of any AE/OOTWG inflatable product on a hard and/or sharp surface (any surface other than grass) without the use of a tarp shall constitute improper usage and any resulting damage or defect shall not be covered by our warranty policy. Any repairs or modifications on any AE/OOTWG product performed by anyone except AE/OOTWG or its authorized agents will not be covered by our warranty policy further, said repairs or modifications will void this warranty completely. AE/OOTWG has the right to require photographic evidence of any defect(s) submitted for warranty claims to aid us in determining a course of action in accordance with our warranty terms. Any defects or damage in any product sold by AE/OOTWG found to be covered by our warranty policy will be repaired or replaced by AE/OOTWG at our discretion.
